TOKAI DENKI powered by TEPCO Partial Reduction of Electricity Charge in Chubu Area

Four subsidiaries of TOKAI Holdings Corporation (Headquarters: Shizuoka-shi, Shizuoka; President & CEO: Katsuhiko Tokita; hereinafter "the Company"), namely TOKAI CORPORATION, TOKAI GAS CORPORATION, TOKAI Communications Corporation, and TOKAI Cable Network Corporation (hereinafter collectively "the TOKAI Group"), will lower the price of electricity charge plans ("Standard S" and "Standard L") provided in the Chubu area *1 from August 1, 2017.

After the upcoming price reduction, electricity charges for "Standard S," the electricity charge plan designed for ordinary households, will be the same as the electricity charge plan "Meter-Rate Lighting B" provided by Chubu Electric Power Co., Inc. (hereinafter "Chubu Electric Power") up to the monthly usage of 120kWh and lower for the amount used above 120kWh.

In the case of changing from Chubu Electric Power's Meter-Rate Lighting B to Standard S, customers will be able to save approx. 3% in their annual electricity charges in each of the following model cases *2:

- Customers with monthly electricity charges of 8,000 yen (30A, approx. 306kWh) can save approx. 2,900 yen/year
- Customers with monthly electricity charges of 12,000 yen (40A, approx. 439kWh) can save approx. 4,300 yen/year
- Customers with monthly electricity charges of 15,000 yen (50A, approx. 536kWh) can save approx. 5,400 yen/year

When monthly electricity usage is 300kWh or above, "Standard L," the electricity charge plan designed for households and stores with large electricity consumption, will be more economical*3 than "Meter-Rate Lighting C" and "Tokutoku Plan" provided by Chubu Electric Power.

No additional process is needed for customers who have already signed up for the plan. New electricity charges will be automatically applied to the amount used from August 1, 2017.

By taking the opportunity of the price reduction, the TOKAI Group will explore potential demand for switching power companies in the Chubu area while making comprehensive proposals for various life infrastructure services that are closely related to customers' daily lives under the "Total Life Concierge (TLC)" vision.

 - Comparison with Chubu Electric Power's "Meter-Rate Lighting B"; Estimates exclude Fuel Cost Adjustment Charges, Renewable Electric Energy Feed-in Tariff, and account transfer discount.
 - TEPCO Energy Partner, Incorporated will grant additional points (5 points/1,000 yen) according to electricity charges (granting points to the amount of electricity bill after excluding the amount equivalent to tax, Renewable Electric Energy Feed-in Tariff, delinquency charges, and others).
 - The TOKAI Group will additionally grant TLC Points (bonus points) according to the number of services provided by the Group (e.g. gas, Internet, CATV). 2. Schedule for application of new charges

New electricity charge will be applied from August 1, 2017.

No additional process is needed for customers who have already signed up for the plan. For August electricity charges, energy charge unit price will be calculated based on the current rate until July 31 and based on the new rate on or after August 1.
