Notice on Acquisition of Radio Station License for Regional BWA System in Koto-ku, Tokyo

TOKAI Holdings Corporation announces that Tokyo Bay Network Co., Ltd. (Head Office: Koto-ku, Tokyo; President and Representative Director: Masahiko Takada; hereinafter "TBN"), its consolidated subsidiary, obtained a radio station license for regional Broadband Wireless Access (BWA) system in Koto-ku, Tokyo, from the Kanto Bureau of Telecommunications of the Ministry of Internal Affairs and Communications effective October 3, 2017.

Regional BWA is a radio system for telecommunications services designed to contribute to promoting regional and public welfare, such as enhancement of public services in the local community and elimination of digital divide (disadvantaged areas), by using radio waves of dedicated frequency bands allocated to each mobile telecommunication service operator.

TBN will use this radio system to develop a disaster prevention network in collaboration with local government, provide services including free Wi-Fi spots, and secure backup line of interchange circuit of community channels, with the purpose of improving profitability in this business area, expanding the customer base, and increasing the corporate value through regional and social contributions.

Under the TLC (Total Life Concierge) vision, the TOKAI Group proposes comprehensive lineup of various lifestyle infrastructure services closely attached to people's lives, including energy, information and communications, and CATV. Currently, 2.57 million customers are using the Group services. Going forward, by continuing to actively work toward providing products and services that can contribute to solving regional and social issues, the Group will aim to improve customer satisfaction.

Notice of Acquisition of Radio Station License for Regional BWA System in Koto-ku, Tokyo by Group Company Tokyo Bay Network

TOKAI Cable Network Corporation (Headquarters: Numazu City, Shizuoka Pref.; Representative Director and President: Yasuhiro Fukuda; hereinafter the "Company") promotes the development of regional BWA services at its group companies.

Regional BWA system uses the frequencies between 2,575MHz and 2,595MHz (regional bands) to provide wireless broadband services according to the characteristics and needs of local communities. Through the provision of regional BWA services, the Company expects to contribute to improving public services, such as elimination of digital divide, and widely provide high-speed data communication services to local residents.

Tokyo Bay Network Co., Ltd. (Head Office: Koto-ku, Tokyo; President and Representative Director: Masahiko Takada; hereinafter "TBN"), a TOKAI Group company, obtained a radio station license for regional BWA base station in Koto-ku, Tokyo, from the Kanto Bureau of Telecommunications of the Ministry of Internal Affairs and Communications effective October 3, 2017.

With this, TBN will promote the development of disaster and crime prevention networks in collaboration with local government and provision of wireless broadband infrastructure available for use by the local community. The company is scheduled to launch services for local government and the general public successively in Koto-ku, Tokyo successively from November.

Services for local government	 Provision of public Wi-Fi spots in public facilities (including evacuation sites, etc.) Backup line for wired networks, etc.
Services for the public	Internet connection services (wireless terminal rental service)
Other services	Provision of backup line of interchange circuit of community channels

The acquisition of the radio station license for regional BWA base station by Tokyo Bay Network marks the first case in the TOKAI Group. The TOKAI Group will continue to promote efforts for the acquisition of license for regional BWA system and launch of services, and provide services that can contribute to improving the lifestyle of local customers.
