Priority Negotiation Right Granted for Transfer of Nikaho City Gas Business

We are pleased to announce as indicated in the attachment document that TOKAI GAS CORPORATION (head office: Yaizu City, Shizuoka Prefecture, Representative Director: Shingo Takahashi, "TOKAI GAS"), our 100% subsidiary, has been granted the priority negotiation right for the transfer of the gas business operated by the City of Nikaho, Akita Prefecture.

As a founding company of our Group, TOKAI GAS operates the city gas business in the Shida Area (Yaizu City, Fujieda City, and Shimada City) in Shizuoka Prefecture. Last year, the company signed an agreement with the Town of Shimonita, Gunma Prefecture, to take over the town's gas business, which is scheduled to begin operation in April this year.

Based on the ideas that the city gas business is closely related to daily life of people living in the service areas and our growth is based on building the relationship of trust with customers, the company is working on (1)strengthening the customer contact with themes closely related to daily life, (2)actively promoting advanced energy systems that make use of our advanced technological capabilities, (3)enhancing trust through various community contribution activities, and (4)becoming a role model business of the Group's TLC vision.

Our Group is promoting a growth strategy centered on the medium-term management plan "Innovation Plan 2020 'JUMP'," which will end in FY2020. Strengthening our core business is one of the priority measures of this plan, and we aim to expand our customer base by extending our city gas business over a wide area. We will contribute to the development of the local community by leveraging strengths our Group has cultivated as a local enterprise.

Priority Negotiation Right Granted for Transfer of Nikaho City Gas Business

We are pleased to announce that TOKAI GAS CORPORATION has been granted the priority negotiation right for transfer of the gas business operated by the City of Nikaho, Akita Prefecture. We will discuss the details of the terms and conditions of the business transfer with the City of Nikaho toward conclusion of a business transfer agreement.

For this business transfer, the City of Nikaho began soliciting applications on July 17, 2018.

After investigating the nature of the business and assessing its profitability, we concluded that our involvement in this business would increase the corporate and shareholder value of the TOKAI Group and contribute to wider use of natural gas and to the benefit of the local community. Following this conclusion, we submitted a business proposal to the City of Nikaho.

After a hearing with the City's committee for selecting the gas business transferee, we were selected as the best proposer. Based on this result, the City of Nikaho considered whom to grant the priority negotiation right and selected TOKAI GAS.

As part of our efforts to take over the gas business the City of Nikaho has operated so far, we will establish safety systems and standards to further improve the level of safety. Based on our Group's TLC (Total Life Concierge) concept for offering customers comprehensive and precise support for comfortable lifestyles, we aim to be a company that contributes to better life of people in Nikaho City and the development of the local community.
